## Relevant Experience Girl Scouts of the Green and White Mountains (NH and VT Statewide)

Banwell was hired to do a comprehensive review of all of the properties the Girl Scouts own in NH and VT (a total of 14 properties). We conducted site visits to each property and developed overall existing site plans of existing facilities. Banwell then lead a series of charrettes, two in NH and one in Vermont.

### Blackstone Valley Regional School District Master Plan (Upton, MA)

Banwell's completed a comprehensive master plan report for the school in order to assist them in moving forward with building decisions. This included review of the existing facility and current programs and recommended renovations to accommodate growth and decline of programs/ space planning.

We are also completing a master plan for their existing campus including: Additions for independent living, nursing, health center, fitness center (pool, locker rooms, exercise rooms and activity room).

#### Jay Peak New Stateside Master Plan (Jay Vermont)

Banwell created a brand new base community plan that included a lodge, hotel, learning center, recreation center, parking, maintenance and central biomass heating facility. We worked with the owners and staff at Jay Peak to develop the programs for each of the buildings and overall cost estimates for the development.
